- Develops a comprehensive, person-centered service plan for each resident and monitors and updates service plan according to program guidelines.
- Supports discharge planning and transition to community with client, nursing facility staff, health plan, and other identified supports.
- Coordinates activities for clients to move into the community.
- Provides comprehensive care management after the client transitions into the community, including coordinating benefits, in-home services and community resources; schedules medical appointments; and advocates for clients as needed.
- Collaborates with partner agencies to facilitate all aspects of the transition.
- May assist with program outreach at select nursing homes.
- Follows all program standards and procedures.

- Master's Degree (MA, MSW) in social work, counseling, psychology, or related field
